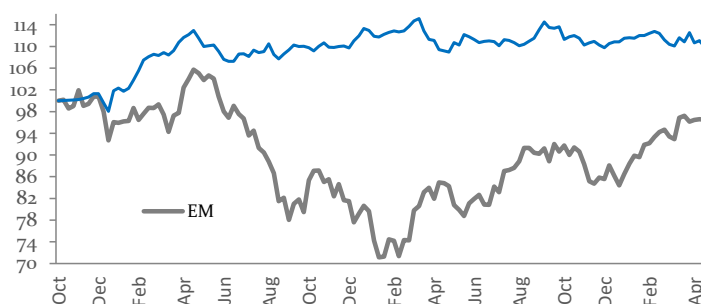

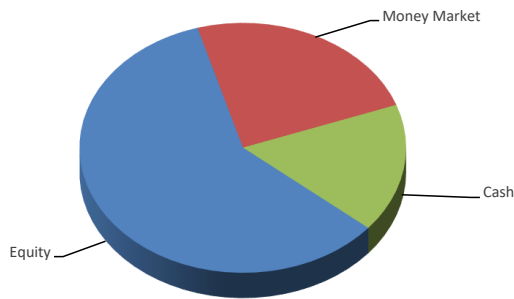

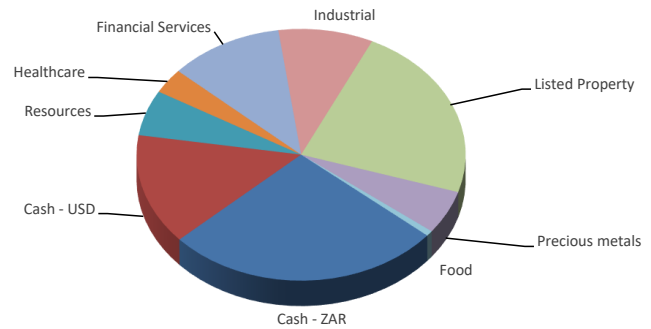
Rock Capital IP Top 20 Global Fund

Fund Commentary (updated quarterly)

The SARB reduced the prime lending rate by a quarter of a percent to 6.75%. This will give some much needed relief for the South African consumer and lift sentiments. This bodes well for the stock market, especially the listed property companies, and fortifies our bullish sentiment when it comes to the high dividend yielding property sector. However, this tentative optimism could still easily be reversed by any political shocks leading up to the ANC December conference.
