

Fund Objective

The Rock Capital IP Top 20 Global Fund is a moderate to high risk, flexible fund. The objective of this portfolio is to achieve capital appreciation over the medium to long term.

Fund Universe

Investments to be included in the ROCK CAPITAL IP TOP 20 GLOBAL FUND will, apart from assets in liquid form, consist of securities and financial instruments across the equity, fixed interest and property markets. The portfolio will typically be highly exposed to equities but the Portfolio Manager will have complete flexibility to vary the exposure to different asset classes as economic conditions vary. The portfolio will typically not hold more than 20 securities at any time.

Manager Commentary

What a quarter this has been! Within the space of three months, South Africa has seen a significant political change, all-time highs in the markets, both locally and in the world at large, and recently a big upswing in volatility.

On the local front, Valentine's Day came with a gift for South Africa, as President Zuma announced his resignation, following pressure from the newly elected ANC NEC. This was swiftly followed by the swearing in of Cyril Ramaphosa as the new head of the Republic. He promptly reshuffled his cabinet, and re-instated Mr Nene as Finance Minister and Mr Gordhan as Public Enterprises Minister, in an effort to bolster the economic cluster.

While the rise in confidence around the country has been palpable, the budget speech did pour some cold water on the rising euphoria. A one percentage point increase in the VAT rate, as well as the announcement of a 52c/l increase in the fuel levy has been poorly received by South Africans, yet these measures, as well as the change in the political landscape were reasons given by Moody's to not change their credit rating for South Africa to sub-investment grade, or junk status, as it is commonly called.

The consequences of being "junked" by all three ratings agencies would have been disastrous for South Africa, so there has been a reprieve, and now it is time for action. As a partial offset to the tax-hikes, the MPC announced a 25 basis point cut in the repo-rate, with another one possibly on the cards for later in the year.

These events saw the Rand trade at three-year lows, touching R11.50/\$. This also saw a boost in the "SA Inc." shares, with local retailers and banks seeing good gains, while rand-hedge shares took some pain. On the 24th of January the All-Share Index had an all-time closing high of 61,623 points. Subsequently there has been a correction in the local as well as world markets.

World markets continued the December rally to all-time highs on the back of extensive tax-cuts in the US. However the continued gradual raising of US interest rates and the heightening of geo-political tensions across the globe, and the spectre of "trade war" between the US and China has seen volatility rise quite sharply towards the end of the quarter.

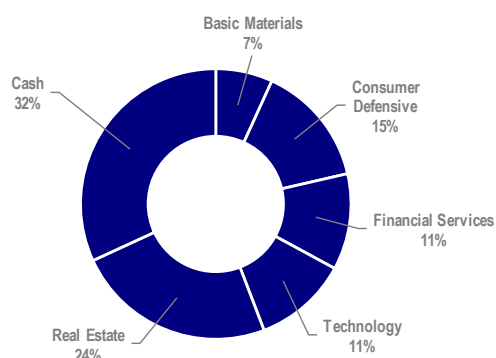

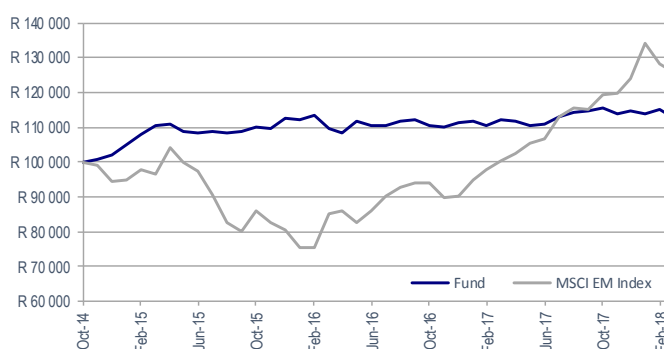

Volatility is a statistical measure of the dispersion of returns for a given security or market index.

Tracking error is a measure of the risk in an investment portfolio that is due to active management decisions made by the portfolio manager; it indicates how closely a portfolio follows the index to which it is benchmarked.

Information ratio, is a measure of the risk-adjusted return of a portfolio. In this case, it measures the active return of the manager's portfolio divided by the amount of risk that the manager takes relative to the benchmark.

Sharpe Ratio is a measure for calculating risk-adjusted return. It is the average return earned in excess of the risk-free rate per unit of total risk. The greater a portfolio's Sharpe ratio, the better its risk-adjusted performance has been (i.e. a higher return with a contained risk profile, where the portfolio manager is not taking excessive risk to achieve those returns).

Beta is a measure of the volatility, or systematic risk, of a security or a portfolio in comparison to the market as a whole.

Alpha is a measure of the active return on an investment. It represents the excess returns of a fund relative to the return of a suitable benchmark.
