

**Fund Objective**

The Rock Capital IP Worldwide Flexible Fund is a moderate to high risk, flexible fund. The objective of this portfolio is to achieve capital appreciation over the medium to long term.

**Fund Universe**

Investments to be included in the ROCK CAPITAL IP WORLDWIDE FLEXIBLE FUND will, apart from assets in liquid form, consist of securities and financial instruments across the equity, fixed interest and property markets. The portfolio will typically be highly exposed to equities but the Portfolio Manager will have complete flexibility to vary the exposure to different asset classes as economic conditions vary. The portfolio will typically not hold more than 20 securities at any time.

**Manager Commentary**

As 2024 draws to a close, the global economy can finally breathe a sigh of relief as we enter the long-awaited phase of rate cuts. Initially anticipated in the first half of the year, persistent inflation delayed central banks' interest rate reductions. With over \$6 trillion globally held in cash or related assets, falling rates are expected to weaken the US Dollar and shift towards a more risk-on environment, benefiting emerging markets, South Africa, and the Rand. However, the escalating conflict in the Middle East, particularly between Israel and Hamas, significantly increases global geopolitical risks. This escalation could disrupt energy supplies, leading to higher oil prices and inflationary pressures. The potential for broader regional involvement, including from Hezbollah and Iran, adds to the uncertainty. Such instability can strain international relations and economic activities, impacting global markets and investor confidence.

China's stimulus measures, including interest rate cuts and increased liquidity, justify stronger cash positions by making borrowing cheaper and enhancing cash flow stability for businesses. For resource positions, the focus on infrastructure projects and construction boosts demand for raw materials, justifying increased resource allocation.

After a decade of stagnant growth, challenging economic conditions, and deteriorating state infrastructure, South African voters have chosen a new direction. This should lead to an improved environment and hopefully better service delivery to those in our country who need it most.

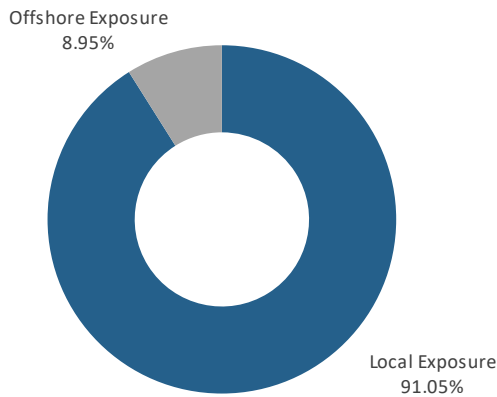

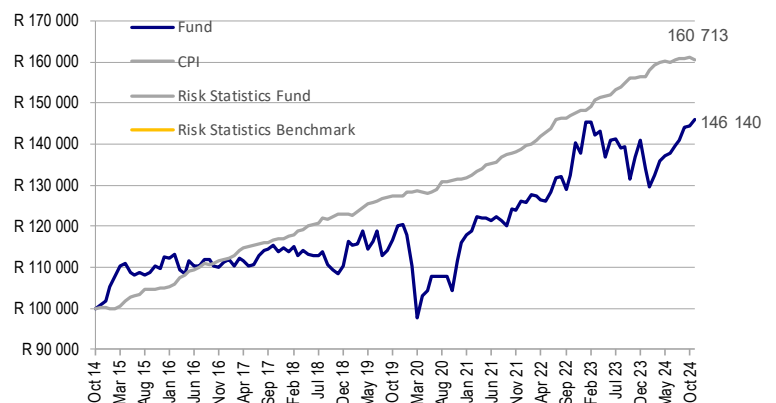

**Volatility** is a statistical measure of the dispersion of returns for a given security or market index.

**Tracking error** is a measure of the risk in an investment portfolio that is due to active management decisions made by the portfolio manager; it indicates how closely a portfolio follows the index to which it is benchmarked.

**Information ratio** is a measure of the risk-adjusted return of a portfolio. In this case, it measures the active return of the manager's portfolio divided by the amount of risk that the manager takes relative to the benchmark.

**Sharpe Ratio** is a measure for calculating risk-adjusted return. It is the average return earned in excess of the risk-free rate per unit of total risk. The greater a portfolio's Sharpe ratio, the better its risk-adjusted performance has been (i.e. a higher return with a contained risk profile, where the portfolio manager is not taking excessive risk to achieve those returns).

**Beta** is a measure of the volatility, or systematic risk, of a security or a portfolio in comparison to the market as a whole.

**Alpha** is a measure of the active return on an investment. It represents the excess returns of a fund relative to the return of a suitable benchmark.
